

The dossier of Greg Carlson '82 reads like St. Olaf's mission statement: He is well-rounded, ethically centered and wholly dedicated to living a life of worth and service.

When he graduated from St. Olaf with a major in economics in 1982, Greg joined IDS/American Express (now Ameriprise) as a financial planner. Just four years later, he carved his own path, first as an independent adviser, then as co-founder of what is now Carlson Capital Management. His company has become one of the top wealth management firms in Minnesota. It employs 18 people in three offices and manages more than \$750 million in assets.

But Greg's contributions go well beyond his portfolio. He has a venerable record of service — to charity, the Northfield community and St. Olaf College. Greg works closely with friends and clients to develop and encourage a strong sense of stewardship to both St. Olaf College and other philanthropic endeavors. In addition to taking leadership roles with numerous charitable organizations, he is a cofounding member of the American Center for Philanthropy, 5th Bridge and the Northfield Area Foundation.

Throughout his career, Greg has hired St. Olaf alumni and interns at his firm, and has worked with St. Olaf seniors to apply the concepts they learned in class to the real world. Twenty-five years after graduating, he still returns to Associate Professor of Economics Mary Emery's classroom — now to talk to students about the importance of planning for retirement.

"Each one of us has an innate calling to act beyond ourselves," Greg says. "There isn't a problem we can't solve by making opportunities for others."
